Please retain this form to document the employee's authorization for this Payroll Deduction plan. For ACH purposes, code this as a checking account. The transit routing number is 10200007-6. For State Street Bank and Trust Company Retirement accounts, the ACH number is 15090 + the two-digit fund number + 0 + the employee's Janus account number. Example: If the employee has Janus Contrarian, Retirement account #12345, the 17 digit number should be entered as 15090610000012345.

For all other accounts, the ACH account number is 14890 + the two-digit fund number + 0 + the employee's Janus account number. Example: If the employee has Janus Contrarian, Non-Retirement account #12345, the 17 digit number should be entered as 14890610000012345.
